
Binational Great Lakes History

- 1909 Boundary Waters Treaty
 - International Joint Commission was established under this Treaty
 - IJC is to advise Canada and U.S. to address issues along common border
- Great Lakes Water Quality Agreement (GLWQA)
 - Canada and U.S. sign agreement for a coordinated cleanup effort for phosphorus pollution in 1972
 - GLWQA has been revised and expanded several times.
 - The 1987 revision (signed in Toledo) included the development of Remedial Action Plans for Areas of Concern



GLWQA – Annex 2

- Areas of Concern (AOCs)
 - 43 areas were identified where the general or specific objectives of the GLWQA were not being met
 - Included major municipal & industrial centers on Gr. Lakes rivers and harbors
- Remedial Action Plans (RAPs)
 - RAPs were envisioned to be plans that would identify the problems and outline how to fix them
 - Impairments to 14 beneficial uses would be the focus (i.e. habitat, beach closings, wildlife deformities, fish consumption, etc.)





RAP Philosophy

- A multi-faceted broad approach is needed to cleanup
 Great Lakes Areas of Concern
- An ecosystem approach needs to be used which considers all pollution sources and their impacts
- A diverse group of individuals is needed to consider all options, development comprehensive plans, and implement successful projects


RAP Process

- The documentation of process and progress is a necessary component of Great Lakes Areas of Concern restoration
- The process developed by the IJC to address the problems of the 43 AOCs includes the creation of 3 Stage "remedial action plans"
 - □ Stage 1 Identification of environmental problems and sources
 - □ Stage 2 Elimination of pollution sources to improve water quality
 - □ Stage 3 Protection of the improved water quality
- The RAPs need to present information based on restoration of 14 Beneficial Use Impairments (BUIs)

Ohio EPA and RAPs

- Ohio EPA is responsible for ensuring Remedial Action Plans (RAPs) are developed and implemented in Ohio's four Areas of Concern (AOCs)
 - □ Maumee River
 □ Black River
 - □ Cuyahoga River
 □ Ashtabula River
- These areas are the State's most polluted and environmentally impacted rivers which empty into Lake Erie
- Each of Ohio's RAPs has been organized differently, depending on the unique characteristics of each AOC, such as:
 - □ environmental problems in the AOC
 - □ sources and causes of the problems
 - available resources both technical and financial
- Local committees in each AOC coordinate the development and implementation of the RAP
- Ohio EPA works with local groups as an equal partner in the RAP process

Ohio's Areas of Concern




Maumee RAP & Partners for Clean Streams

- Housed with a local Council of Governments for nearly 20 years, the Maumee RAP has now grown to establish its own 501(c)3 nonprofit organization, Partners for Clean Streams (PCS).
- The Mission of PCS is to strive for abundant open space and a high quality natural environment; adequate floodwater storage capacities and flourishing wildlife; stakeholders who take local ownership in their resources; and rivers, streams, and lakes that are clean, clear and safe.
- PCS currently facilitates its partners through planning, implementation, and organizational sustainability utilizing a part-time Executive Director that assists with managing the implementation projects, ongoing annual community projects, and overall PCS administration/ budgeting.
- The Maumee RAP is an Advisory Committee under PCS focused on restoring the Beneficial Uses of the Maumee AOC through project identification, development and implementation.

Give Water a Hand Campaigns

- One of the most successful environmental awareness campaigns in Northwest Ohio
- Over 20 communities and organizations partnered together
- The Residential Campaign received two awards in 2006:
 - □ Honorable Mention from the National Association of Regional Councils
 - □ Ohio Environmental Education Fund Outstanding Environmental Ed. Project

Residential Campaign:

Conducted in 2004-05 to educate residents about storm water and other environmental issues, their impact on water quality, and how the average citizen can help. This multi-media campaign included the quarterly mailing of tip cards, newspaper, cinema, and television ads, press releases, posters, and public service announcements (PSAs).

Business Campaign:

Conducted in 2006 to inform local business owners, managers, and employees of the proper methods of storage, use, and disposal of a wide variety of materials that can help them to save money and prevent pollution. Guidebooks were created focusing on four business sectors.

Watershed Awareness Campaign:

Conducted in 2005-06 to inform residents and visitors alike of what watershed they are in. Signs have been posted at bridge crossings and/or other locations where high public awareness and impact is needed, such as illegal dumping areas. Over 250 signs were posted in 2005 and 2006 in 6 watersheds.





Community Outreach and Education

- 12th Annual Clean Your Streams Day
 - Saturday, September 13, 2008
 - □ 603 participated in 2007
 - 20,123 lbs of garbage in 2007
 - □ Over 47 tons collected in 11 years
- Partnering for Clean Streams Patch Program
 - Youth learn about their watershed and factors that are influencing our area's water quality
 - Requirements can be completed independently or at a half-day workshop held each April
- 4th Annual Get the Lead Out! Cleanup
 - □ Over two weeks from May 23 to June 9, 2008
 - □ Pick up fishing line, lead and lures after the fish spawning run the Maumee River
 - Along the Maumee River near Sidecut Metropark in Maumee and Orleans Park and Fort Meigs in Perrysburg

 PCS was one of four organizations to receive funds from The Joyce Foundation as a part of a \$5 million

The Joyce Foundation

Maumee Initiative: Great River, Great Lakes

- investment in the Maumee River watershed called the Great River Great Lakes Initiative
- The grant is to implement 3 projects that would improve the quality of the lower end of the Maumee River and of Lake Erie, in terms of both water quality and ecosystem function
- These projects have a direct impact, but also represent and demonstrate solutions to the problems of urban, industrial areas
 - Risk Assessments
 - To prepare for Great Lakes Legacy Act application, if necessary
 - Dam Mitigation
 - Mitigate effects of dam without removing it
 - □ Inventory & Restoration Plans
 - Prioritize and plan for future projects opportunities
