

Maumee AOC

Maumee AOC covers 787 mi, encompassing the greater-Toledo area and large tracts of land to the west and southwest of Toledo. In total, 57 communities of all sizes are spread across this area, and roughly 558,000 people call it home. The Maumee AOC includes approximately 45 miles of Lake Erie shoreline and over 1900 miles of stream in 11 independent watersheds. Land use in the AOC is diverse, representing urban and rural developments, agriculture, and pockets of native forests, prairies, and wetlands. This area is designated as an AOC due to human activities (industry, agriculture, shipping, etc.) that have impaired the human use (i.e., drinking water, fish consumption, recreation) and ecological use (i.e., habitat, aquatic population, wildlife diversity).









AOC Program

In 1987, the joint US-Canada Great Lakes Water Quality Agreement amendments formed the Area of Concern (AOC) program. This program, specific to the Great Lakes Region, identified 43 "Areas of Concern" surrounding the Great Lakes that exhibited such degrees of environmental degradation that they posed risks to the overall health of the Lakes, the wildlife that depend on them, and the people that use the resources.



Delisting the Maumee AOC

Delisting or removing the Maumee from the AOC program list requires the restoration of a suite of impaired environmental uses. These impairments are called beneficial use impairments (BUIs), which are defined as reductions of the chemical, physical, or biological integrity of the waters of an Area of Concern sufficient to cause one of fourteen impairments identified in the Great Lakes Water Quality Agreement. A BUI may be removed from a discrete area (AOC-wide or individual watershed) when the applicable target value for that area (e.g., habitat score, chemical concentration, etc.), set by the State of Ohio, is met.

The Maumee AOC began with the 10 BUIs listed below. As work to remove the remining BUIs is a dynamic process, the status of a BUI can change from one year to another. Please see the Data Management and Delisting System (DMDS; https://dmds.maumeerap.org) for the most upto-date information regarding a particular BUI.

BUI 1: Restrictions on fish and wildlife consumption

BUI 3: Degradation of fish and wildlife populations

BUI 4: Fish tumors or other deformities

BUI 6: Degradation of benthos

BUI 7: Restriction on dredging activities

BUI 8: Eutrophication or undesirable algae

BUI 10: Beach closings

BUI 11: Degradation of aesthetics

BUI 12: Added costs to agriculture or industry:

BUI 14: Loss of fish and wildlife habitat

Each AOC may be delisted after undergoing steps 1-6 below for each designated BUI:



1. Monitoring and Assessment



2. Management Action Project (MAP) List in Development



3. MAP Implementation



4. Meet BUI Restoration Targets



5. Formal BUI Removal



6. Formal AOC Delisting







What Are Partners Doing?

Projects to help the AOC recover can use a variety of strategies and approaches. These can include addressing sediment contamination, creating healthier habitat for fish and wildlife, and restoring degraded habitat. Larger projects are usually facilitated through successful community and organizational partnerships.

Some of the general strategies that have been employed to address/remove various BUIs are listed to the right.

- Restoration and enhancement of native forest and prairie habitat
- · Restoration and enhancement of instream habitat
- Enhancement of stream and river riparian buffers
- · Enhancement of wetland and stream connectivity
- Removal of contaminated sediment
- Reduction of bacterial contamination
- Reduction of sediment and nutrient runoff
